

Livestock Hay and Feed Donation Request

With the recent wildfires in Oregon, many livestock owners do not have enough feed to provide for their animals throughout this crisis. Oregon State University Extension is partnering with state and local emergency operations, county fairgrounds, and individuals across the state to solicit hay, livestock feed, and monetary donations. We are also helping to coordinate the transportation of donations to the affected areas in partnership with Oregon Cattleman Association.

Hay will be needed for livestock and grain will be needed for swine and poultry. It is important hay and feed donations be of good quality (i.e. not moldy or rotten as it may make the animals sick).
